HEARTHSTONE WATER INC.'S SUPPLEMENTAL APPLICATION INFORMATION





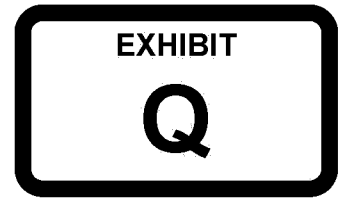
