HEARTHSTONE WATER, INC.'S REQUEST TO MODIFY DEADLINE

On February 7, 2023, Hearthstone Water, Inc., a Texas corporation (Hearthstone), together with and as authorized by The Kauffman Family Living Trust, Dated April 9, 2015, Disciple Asset Holdings, LP, and Malakoff Family Holdings, LP (Sellers) and Triton Texas Holdings LLC, a Texas limited liability company (TTH) (collectively, the Applicants), filed the application that is the subject of this docket (Application). Order No. 1 established March 29, 2023 as the deadline for Commission Staff (Staff) to file comments on the administrative completeness of the Application. Hearthstone hereby requests on behalf of itself and the other Applicants that Staff's deadline be shortened. In support, Hearthstone shows as follows.

The Applicants would like to obtain approval for the transaction proposed in the Application as soon as possible. Applications filed under Chapter 24 of the Commission rules, such as this one, are generally required to "be reviewed for administrative completeness within 30 days from the date the application is file stamped by the commission's Central Records office."² Therefore, Hearthstone submits that the deadline for Staff's initial review should be March 9, 2023

instead of March 29, 2023. Hearthstone respectfully requests that the procedural schedule for this docket be revised accordingly.

Conclusion

For the reasons described above, Hearthstone respectfully requests the presiding Commission Administrative Law Judge (ALJ) adopt a modified procedural schedule that would move Staff's deadline to comment on the administrative completeness of the Application to March 9, 2023.
