**ORDER NO. 4  
GRANTING INTERVENTION**

This Order addresses Aqua Texas, Inc.'s June 5, 2023 motion to intervene in this proceeding.

Aqua Texas presented a justiciable interest that may be adversely affected by the outcome of this proceeding. No party objected to the motion. Accordingly, the administrative law judge grants the motion.

All parties must provide their current address, **e-mail address**, telephone and fax numbers, if available, to all other parties and the Commission by filing and serving all parties with such information. Each party must provide the Commission and all parties with updated address, **e-mail address**, telephone, and fax information if such information changes. **The e-mail addresses**, telephone and fax numbers will be placed on the service list for the convenience of the parties.

As long as the Second Order Suspending Rules remains in effect, all parties must file any pleading or document with the Commission solely through the Interchange on the Commission's website (<https://interchange.puc.texas.gov/filer>) and provide notice, by e-mail, to all other parties that the pleading or document has been filed with the Commission, unless otherwise ordered by the presiding officer. It will be incumbent upon all other parties to obtain a copy of the pleading or document by accessing the Interchange.**
