



Water bill Acct# 104856 over 5 times more than electric bill with NO prior notice (before new service started) that there would be a non refundable (until service permanently ended) deposit of \$240 not allowing a letter of credit instead as the electric providers Do NOT allow a return of the deposit after a set time of on time payments... in addition NO prior notice was given about a required \$50 charge for an inspection fee for new service customers... requesting information on state agencies that regulate these areas and want all ancillary charges (NOT fully disclosed UPFRONT with appeals process etc) credited back to me since these charges were already paid as part of the initial bill in order to maintain service for this essential utility (WATER).
