HIGH POINT SPECIAL UTILITY DISTRICT'S RESPONSE TO ORDER NO.1

High Point Special Utility District (High Point SUD) files this response to Order No.1 and respectfully shows the following:

I. BACKGROUND

On February 17, 2023, Evelyn Dangerfield (Ms. Dangerfield) filed with the Public Utility Commission of Texas (Commission) an appeal of the cost of obtaining service from High Point SUD under Texas Water Code (TWC) § 13.043(g) and 16 Texas Administrative Code (TAC)§ 24.101(g).

On February 22, 2023, the administrative law judge (ALJ) issued Order No. 1, directing Ms. Dangerfield, High Point SUD, and Commission Staff to file recommendations regarding how to proceed with the appeal and to propose a procedural schedule by March 17, 2023. Therefore, this pleading is timely filed.

II. HOW TO PROCECED

Billing disputes are handled via the Commission complaint process pursuant to 16 TAC § 22.242. Therefore, Ms. Dangerfield's appeal should be dismissed without prejudice under 16 TAC §22.181(d)(5) and (d)(11).

III. PROCEDURAL SCHEDULE

In accordance with High Point's position state in Section II above, High Point SUD does not propose a procedural schedule for further processing of this docket. High Point SUD will submit a proposed procedural schedule should the ALJ decline to dismiss the appeal.

IV. CONCLUSION

For the reasons stated above, High Point SUD requests entry of an order dismissing the appeal and closing this docket.
