**COMMISSION STAFF'S RECOMMENDATION ON ADMINISTRATIVE
COMPLETENESS AND FINAL DISPOSITION**

On February 14, 2023, Parkview Water Supply (Parkview) filed an application for a Class D rate adjustment under Texas Water Code (TWC) § 13.1872 and 16 Texas Administrative Code (TAC) § 24.49. Parkview holds Certificate and Convenience and Necessity (CCN) Nos. 12287 and 20717 and is requesting an increase in water and sewer rates.

On May 30, 2023, the administrative law judge (ALJ) filed Order No. 5, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file supplemental comments on the administrative completeness of the application and notice and file a recommendation on final disposition, including, if necessary, a proposed tariff sheet reflecting the requested rate change if appropriate by June 23, 2023. Therefore, this pleading is timely filed.

I. ADMINISTRATIVE COMPLETENESS

To date, Parkview has yet to file supplemental information in response to the letter of deficiency filed on March 8, 2023. Therefore, Staff recommends that the application is administratively incomplete. Staff further recommends that Parkview be ordered to cure the deficiencies identified in Ms. Eiland's memorandum by July 7, 2023, and that Staff be given a deadline of July 21, 2023, to file a supplemental recommendation on the administrative completeness of the application and notice.

II. CONCLUSION

For the reasons detailed above, Staff recommends that the supplemented application be found administratively incomplete, and that Parkview be ordered to file supplemental information to cure the deficiencies in the application by July 7, 2023. Staff respectfully requests the entry of an order consistent with these recommendations.
