COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

I. INTRODUCTION

On February 24, 2023, Enviro-Management filed an application for authority to change water rates under Texas Water Code §§ 13.1871 and 13.1872(c)(2). Enviro-Management is a Class D water utility with 110 active connections and holds Certificate of Convenience and Necessity No. 12625.

On June 14, 2023, the administrative law judge filed Order No.7, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of notice by June 23, 2023. Therefore, this pleading is timely filed.

II. RECOMMENDATION ON SUFFICIENCY OF NOTICE

The notice that Enviro-Management filed on June 2, 2023, was the same notice Enviro-Management filed confidentially on April 11, 2023. In its May 31, 2023 filing, Staff recommended that Enviro-Management's notice be deemed sufficient and also recommended that Enviro-Management resubmit its notice as a public document. As Enviro-Management's June 2, 2023 filing was in response to Staff's recommendation to file the notice as a public document and since nothing in the notice has changed since Staff submitted its recommendation on May 31, 2023, Staff continues to recommend that Enviro-Management's notice be deemed sufficient.

III. CONCLUSION

For the reasons detailed above, Staff respectfully requests that Enviro-Management's notice be deemed sufficient.
