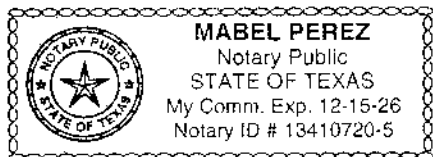

Enviro-Management filed with the Public Utility Commission of Texas (Commission) an application for rate/tariff change on February 24, 2023. The proposed rate and tariff changes will affect you as a ratepayer of Enviro-Management. The application was assigned SOAH Docket No. 473-24-00831.WS. On October 17, 2023, the Administrative Law Judge set a prehearing conference with the following details:

At the prehearing conference, the parties should be prepared to discuss procedures, pending motions, possible settlement of issues, the procedural schedule (including the hearing date), whether notice has been provided to the Office of Public Utility Counsel, and other matters that may aid in efficient and fair processing of this case.

To participate as a party in this case, a person shall move to intervene either (1) in a written motion to intervene filed at the commission **by no later than November 24, 2023**; or (2) **orally at the November 29, 2023, prehearing conference**. Any filed motion shall include both SOAH Docket No. 473-24-00831.WS and PUC Docket No. 54683, the person's contact information, and otherwise comply with the Commission's procedural rules. Previous submission of a protest **DOES NOT** meet the requirement that a person who wants to participate as a party must move to intervene as described above.
