## COMMISSION STAFF'S THIRD REQUEST FOR EXTENSION

On February 27, 2023, ratepayers of Frankston Rural Water Supply Corporation (Frankston RWSC) filed a petition appealing the cost of obtaining service.

On April 26, 2023, the administrative law judge (ALJ) filed Order No. 3, setting a deadline of June 9, 2023, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the petition and on whether this docket should be processed as a complaint, rather than an appeal, and to propose a procedural schedule. Therefore, this pleading is timely filed.

# I. REQUEST FOR EXTENSION

In accordance with 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On May 11, 2023, Nikki Delaney, the only ratepayer that has participated in this docket, filed a request to withdraw. On May 18, 2023, the ALJ filed Order No. 4 which directed the petitioners to amend the motion to withdraw before it could be considered by the ALJ. Staff respectfully requests that the deadline to file its recommendation be extended to July 7, 2023, to provide the petitioners with time to consider whether they want to withdraw from the case and, if so, to amend their motion to withdraw.

#### II. CONCLUSION

Staff respectfully requests entry of an order consistent with this pleading.
