JOINT MOTION TO ADMIT SUPPLEMENTAL EVIDENCE

I. INTRODUCTION

On March 3, 2023, Albury Manor Utility Company, Inc. (AMUC) filed an application under 16 Texas Administrative Code (TAC) § 24.25(b)(2) for approval of a pass-through rate change for certain districts related to a decrease in direct costs associated with North Harris County Regional Water Authority's (NHCRWA) water pumpage fees. AMUC supplemented its application on March 20, 2023, and July 13, 2023.

On July 18, 2023, the administrative law judge (ALJ) filed Order No. 4, directing the parties to request that the supplemental information filed by AMUC on July 13, 2023, be admitted as evidence in the record of this proceeding by July 28, 2023. Therefore, this pleading is timely filed.

II. MOTION TO ADMIT SUPPLEMENTAL EVIDENCE

AMUC and the Staff (Staff) of the Public Utility Commission of Texas (Commission) move to admit the following item into the record of this proceeding:
