TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW, the City of Carbon and notifies the Administrative Law Judge that Applicant is requesting an extension to acquire a signed city council meeting minutes support Docket. No. 54718 in this matter. The City requests 30 days to procure and file the attested document after the scheduled council meeting of March 31, 2024.

Please see the response to the Commission Staff Recommendations of March 6, 2024 for the application of the City of Carbon, TX to take over the two facility lines from Staff WSC (CCN 11155) known as Kokomo and Flatwood.

The City of Carbon has a regularly scheduled city council meeting on March 31, 2024. Included in the agenda are items regarding the transaction between Staff WSC and the City of Carbon. In particular a report outlining the items below:

Receive a report and hold a discussion on the finalizing of the Staff WSC Kokomo and Flat water customers acquisition to submit documents to the Public Utility Commission for approval

- Staff returned customer deposits by December 21, 2023
- New accounts for 92 former Staff WSC customers were set up by the City of Carbon
- Radio read meter installation was completed for the February billing by the City of Carbon
- All components of the October 17, 2022 Staff WSC board action and the October 18, 2022 City of Carbon action have been met.

The transition of service from Staff WSC to the City of Carbon is complete and signed documents will be available after the council meeting.
