ORDER NO. 12
FINDING CLOSING DOCUMENTS, AS SUPPLEMENTED, SUFFICIENT AND
ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the closing documents filed by Staff Water Supply Corporation and City of Carbon.

On December 20, 2023, and January 19, 2024, the applicants filed monthly status reports. On February 20, 2024, the applicants filed a monthly status report in which the applicants stated that the transition of service from Staff WSC to the City of Carbon was complete.

In Order No. 9 filed on March 11, 2024, the administrative law judge (ALJ) found the closing documents deficient and ordered the applicants to cure the deficiencies.

On April 16, 2024, the applicants filed documents in response to Order No. 9. On April 19, 2024, the applicants filed a monthly report regarding two facility lines. On May 17, 2024, the applicants filed a monthly status report in which the applicants stated that the transition of service from Staff WSC to the City of Carbon is complete. On May 30, 2024, the applicants filed the affidavit of Corey Hull, mayor of the City of Carbon, attesting that all customer deposits have been returned.

On June 20, 2024, Commission Staff filed a supplemental recommendation on the closing documents, as supplemented.


The administrative law judge finds the closing documentation sufficient.
