COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND NOTICE AND PROPOSED PROCEDURAL SCHEDULE

On March 7, 2023, Staff Water Supply Corporation (Staff WSC) and City of Carbon (City) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Eastland County under the provisions of Texas Water Code § 13.301 and 16 Texas Administrative Code (TAC) § 24.239. Applicants supplemented the application on April 25, 2023, and May 5, 2023.

On April 10, 2023, the administrative law judge (ALJ) filed Order No. 2, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation on the administrative completeness of the application, proposed notice and propose a procedural schedule by June 5, 2023. Therefore, this pleading is timely filed.

I. ADMINISTRATIVE COMPLETENESS

Staff has reviewed the application and supplemental information and, as detailed in the attached memoranda from Jolie Mathis, Infrastructure Division, and Fred Bednarski III, Rate Regulation Division, Staff recommends that the supplemented application is administratively complete. Staff's recommendation on administrative completeness is not a comment on the merits of the application.

II. NOTICE

At this time, Staff recommends that the Applicants proceed with providing public notice to all current customers, neighboring utilities, political subdivisions, and other persons listed in the attached memorandum using the notice form provided by Ms. Mathis. Along with each individual notice, Staff recommends that the Applicants provide a copy of the maps deemed sufficient during administrative review delineating the requested service area.

Once notice has been provided, Staff recommends that the Applicants file proof of notice as described in the attached memorandum, including an affidavit specifying the name and address of every person and entity to whom notice was provided, the date that the notice was provided, and a copy of the map provided with the notice. Finally, Staff recommends that the Applicants use the attached notice and affidavit to meet these requirements.

III. PROCEDURAL SCHEDULE

Staff recommends that the application, as supplemented, be found administratively complete. Therefore, Staff proposes the following procedural schedule.

City of Carbon (Carbon) and the Staff Water Supply Corporation (Staff WSC) (collectively, Applicants) filed an application for sale, transfer, or merger (STM) of facilities and certificate rights in Eastland County, Texas, under Texas Water Code (TWC) § 13.301 and 16 Texas Administrative Code (TAC) § 24.239.

Specifically, Carbon seeks approval to acquire facilities and to transfer a portion of the water service area from Staff WSC under water CCN No. 11155 and obtain a new CCN number.

Based on the mapping review by Dave Babicki, Infrastructure Division, the revised maps and digital mapping data submitted with Item 6 on May 5, 2023 are sufficient.

- The requested area north includes approximately 426.6 acres, comprised of facility line + 200 feet CCN service area transferred from Staff WSC (CCN No. 11155) to Carbon with the issuance of a new water CCN number.
- The *requested area south* includes approximately 764.2 acres, comprised of facility line + 200 feet CCN service area transferred area from Staff WSC (CCN No. 11155) to Carbon with the issuance of a new water CCN number.
- The total requested area includes 92 customer connections and approximately 1,190.8 acres, comprised of facility line + 200 feet CCN service area transferred area from Staff WSC (CCN No. 11155) to Carbon with the issuance of a new water CCN number.
- The application proposes the subtraction of approximately 1,190.8 acres from CCN No. 11155 and the addition of approximately 1,190.8 acres to Carbon with the issuance of a new water CCN number.

• The application indicates that the total acreage being requested is approximately 1,109.9 acres, however, the mapping review determined the requested area is approximately 1,190.8 acres.

Based on the mapping review and my technical and managerial review of the additional information filed on May 5, 2023, I recommend that the application be deemed administratively complete. I further recommend that the Applicants be ordered to do the following:

- 1) Provide notice of the application by first-class mail to the following:
 - a. Cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area:
 - Brazos River Authority
 - City of Eastland (CCN No. 10470)
 - Eastland County Water Supply District
 - Westbound Water Supply Corporation (WSC) (CCN No. 11831)
 - b. The county judge of each county that is wholly or partially included in the requested area:
 - Eastland County Judge
 - c. Each groundwater conservation district that is wholly or partially included in the requested area:
 - None
 - d. Any affected customers, and other affected parties in the requested area.

Addresses can be obtained from the Water Utility Database at http://www.puc.texas.gov/watersearch. District information and addresses can be obtained from the Texas Commission on Environmental Quality's (TCEQ) web site located at https://www14.tceq.texas.gov/iwud/index.cfm.

- 2) Publish notice once each week for two consecutive weeks in a newspaper having general circulation in the county where the requested area is located. Proof in the form of a publisher's affidavit must be filed within 30 days of the publication date. The affidavit must state with specificity each county in which the newspaper is of general circulation. Within 30 days of the date the notice was mailed, Carbon must file an affidavit specifying the notice that was provided to every person and entity to whom notice was provided and the date the notice was mailed.
- 3) Provide notice using the attached notice forms.
- 4) Provide a copy of the maps deemed sufficient during administrative review delineating the requested area with each individual notice to neighboring utilities, other affected parties, and customers.

- 5) File in the docket:
 - a. A copy of the notices (1 copy of each).
 - b. The general location and detailed maps deemed sufficient during administrative review.
 - c. The signed affidavits for published notice and mailed notices.
 - d. A list specifying every person and entity to whom notice was provided.
 - e. The publisher's affidavit and tear sheets for proof of newspaper publication.
- 6) Supplement the application with a copy of the approval letter for new facilities Carbon will be building to provide additional water service for the requested area from TCEQ once it is it is received. Carbon must file the approval letter prior to Staff making a final recommendation on the application.

Staff may determine that additional information is needed to make a final recommendation in this docket. If additional information is needed, Staff may send requests for information (RFI) to Carbon and Staff WSC. Carbon and Staff WSC will have 20 days from the receipt of the RFI to respond.
