UNOPPOSED REQUEST FOR CONTINUED ABATEMENT WITH GOOD CAUSE

On March 15, 2023, Applicant T & W Water Service Company dba Blue Topaz Utilities filed an application to amend its certificate of convenience and necessities (CCN) in Fort Bend County. T & W Water Service Company dba Blue Topaz Utilities holds Water CCN No. 12892 and Sewer CCN No 21127.

Pursuant to Order # 7, T & W Service Company dba Blue Topaz Utilities (Applicant) is ordered to file its TCEQ approval letter for is distribution system and the parties to file a proposed procedural schedule for further processing of this docket on January 12, 2024, or show good cause as to why applicant is requesting continued abatement. Therefore, this is timely filed.

In response to the ALJ's request, T & W Service Company DBA Blue Topaz Utilities submits the following:

On September 25, 2023, the Texas Commission on Environmental Quality (TCEQ) received from WaterEngineers, Inc. (WaterEngineers), on behalf of Blue Topaz, the request for the approval of the Distribution System. This submittal was assigned TCEQ Project Log No. P-11292023-219. On November 21, 2023, the TCEQ requested additional information to complete the review. On November 29, 2023, WaterEngineers supplied that information, along with a request for Expedited Review.

The applicant has been diligent in providing the necessary information to the Texas Commission on Environmental Quality (TCEQ) to process the approval of the distribution lines. WaterEngineers was notified by TCEQ staff on January 11, 2024, that the Distribution System has received Staff approval and has been submitted for Managerial Approval, and upon Managerial Approval the Letter of Approval will be issued.

Applicant respectfully requests the abatement be continued for 30-days to afford the Texas Commission on Environmental Quality (TCEQ) sufficient time to issue the letter of Approval of the distribution lines. Applicant has conferenced with Staff and can represent that Staff is unopposed to this request.
