**COMMISSION STAFF’S PROPOSED PROCEDURAL SCHEDULE**

On March 15, 2023, T & W Water Service Company dba Blue Topaz (Blue Topaz) filed an application to amend its Certificates of Convenience and Necessity (CCN) in Fort Bend County. Blue Topaz holds water CCN No. 12892 and sewer CCN No. 21127.

On January 23, 2024, the administrative law judge (ALJ) filed Order No. 9, which directed Blue Topaz and Staff (Staff) (collectively, Parties) of the Public Utility Commission of Texas (Commission), to confer and file a proposed procedural schedule for continued processing of this application by February 12, 2024. Therefore, this pleading is timely filed.

**I. PROCEDURAL SCHEDULE**

Parties propose the following procedural schedule:

Deadline for applicant to file signed consent forms with the Commission	March 20, 2024
If no hearing is requested, deadline for Staff to file a final recommendation on the application	April 3, 2024
If no hearing is requested, deadline for Parties to file joint proposed findings of fact, conclusions of law, and ordering paragraphs	April 24, 2024
