**COMMISSION STAFF’S SECOND SUPPLEMENTAL MOTION TO ADMIT

I. BACKGROUND

On March 15, 2023, Applicant filed an application with the Public Utility Commission of Texas (Commission) to amend its Certificate of Convenience and Necessity (CCN) in Fort Bend County. Specifically, Applicant seeks to amend its water service area under water CCN number 12892 and sewer CCN number 21127.

On June 18, 2024, the ALJ filed Corrected Order No. 13, establishing a deadline of July 3, 2024, for T & W Water Service Company DBA Blue Topaz Utilities (Blue Topaz) and Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a motion to admit proof of publication in the Texas Register.
