AFFIDAVIT OF CLAY HODGES

BEFORE ME, the undersigned authority, on this day personally appeared CLAY HODGES, who, after being by me duly sworn, on his oath stated as follows:

- 1. "My name is Clay Hodges. I am the General Manager of Cash Special Utility District ("<u>Cash SUD</u>"). I am over the age of 18 years, of sound mind, and am capable of making this Affidavit. The facts stated in this Affidavit are within my personal knowledge and are true and correct.
- 2. On September 27, 2021, the Board of Directors Cash SUD held a regular meeting at which it considered and approved the Agreement for Transfer of Certificated Water Service Territory with Royse City pursuant to Texas Water Code § 13.248 and 16 Texas Administrative Code § 24.253 and providing for the transfer of certain certificated water service territory from Cash SUD's water CCN No. 10824 to Royse City's water CCN No. 12827. The lands that are the subject of the Service Territory Agreement approved by the Board of Directors of Cash SUD are the same lands that are the subject of the Petition to the Public Utility Commission of Texas in Docket No. 54785.
- 3. Notice of the meeting of the Board of Directors of Cash SUD at which it approved the Service Territory Agreement was given by posting in accordance with the requirements of the Open Meetings Act of Texas. A true and correct copy of said meeting notice is attached as **Exhibit "A"** to this Affidavit.
- 4. Cash SUD supports the "Petition for Royse City and Cash SUD" for Approval of a Service Area Contract under Texas Water Code § 13.248 and to Amend Certificates of Convenience and Necessity in Rockwall County.
