**COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON NOTICE**

**I. INTRODUCTION**

On March 21, 2023, Cash Special Utility District (Cash SUD) and the City of Royse City filed a petition for approval of a service area contract under Texas Water Code § 13.248 and to amend certificates of convenience and necessity in Rockwall County.

On August 30, 2023, the administrative law judge filed Order No. 5, directing the Staff (Staff) of the Public Utility Commission of Texas to file a supplemental recommendation on notice by September 26, 2023. Therefore, this pleading is timely filed.

**II. SUPPLEMENTAL RECOMMENDATION ON NOTICE**

On August 30, 2023, Cash SUD filed a signed and notarized affidavit attesting to the date that meeting notice was provided. Therefore, Staff recommends that notice is sufficient.
