ORDER NO. 6 FINDING PETITION, AS SUPPLEMENTED ADMINISTRATIVELY COMPLETE, FINDING NOTICE SUFFICIENT, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the administrative completeness and sufficiency of notice of Cash Special Utility District and Royse City's March 21, 2023 petition for approval of a service-area contract under Texas Water Code § 13.248 and to amend certificates of convenience and necessity in Rockwall County. The petitioners filed supplemental information on April 13, July 20, and August 30, 2023.

On April 13, 2023, the petitioners filed the following: (a) a copy of Royce City's city council meeting minutes and agenda, supported by affidavit, for the meeting during which the service-area contract was discussed and approved; and (b) a copy of Cash SUD's board meeting minutes and agenda, supported by affidavit, for the meeting during which the service-area contract was discussed and approved.

On August 21, and September 26, 2023, Commission Staff filed a supplemental recommendation regarding the sufficiency of the petition and notice.

The administrative law judge (ALJ) finds the petition, as supplemented, administratively complete and notice sufficient.

The ALJ establishes the following procedural schedule for continued processing of the petition:
