**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On March 21, Cash Special Utility District (Cash SUD) and Royse City (collectively, the Petitioners) filed a petition for approval of a service area contract under Texas Water Code (TWC) § 13.248 and to amend certificates of convenience and necessity in Rockwall County.

On November 28, 2023, the administrative law judge filed Order No. 7, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a joint motion to admit evidence and a proposed order by December 12, 2023.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 TAC § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff and Petitions need more time to finalize the proposed order that parties were directed to file. Staff accordingly respectfully requests an extension of time until December 20, 2023, to file a joint motion to admit evidence and a proposed order.
