APPLICANT'S REQUEST FOR EXTENSION

On April 12, 2024, the presiding Commission Administrative Law Judge ("ALJ") issued Notice of Approval ("Notice") addressing the City of Donna's ("Donna" or "Applicant") application to amend its certificate of convenience and necessity (CCN) number 20825 to add approximately 81 uncertificated acres in Hidalgo County. By the Notice, the Commission amended Donna's CCN number 20825 to add the requested area to the extent provided therein. Specifically, the Notice provides that Donna must comply with the recording requirements of TWC § 13.257(r) and (s) for the area in Hidalgo County affected by this application by recording a certified copy of the approved maps and certificates, along with a boundary description of the service area, in the real property records of Hidalgo County within 31 days of the Notice of Approval. Additionally, Applicant must submit evidence of the recording in the real property records of Hidalgo County to the Commission. no later than 45 days after its receipt of the Notice of Approval.

I. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. The Applicant has determined that additional time is required to complete an accurate boundary description of its service area. The need for the requested extension is not caused by the neglect, indifference, or lack of diligence of the Applicant. Therefore, Applicant respectfully requests that the deadline to file the copy of the approved maps and certificates, along with a boundary description of its service area, in the real property records of Hidalgo County be extended to June 11, 2024, being 60 days from the

issuance of the Notice of Approval. Applicant further requests that the deadline to submit evidence of the recording in the real property records of Hidalgo County to the Commission be extended to June 26, 2024, being 75 days from the issuance of the Notice of Approval.

II. CONCLUSION.

Applicant respectfully requests entry of an order consistent with this pleading.
