## RESPONSE TO STAFF'S FIRST REQUEST FOR INFORMATION

**Staff 1-1** Question 22 of the application indicates the number of additional water and sewer connections as 1000, but submitted documentation indicated 923 lots. Please provide additional details as to the correct projection.

Answer: The contract refers to approximately 1000 connections; however, it is only an estimate and subject to change as shown in the land plan and the latest facility map.

**Staff 1-2** For the requested area. Provide a map (or maps) showing all the facilities for production, transmission, and distribution in conjunction with the location of existing or proposed customer connections in the requested area. Facilities should be identified on the subdivision plats, engineering planning maps or other large-scale maps.

Staff 1-3 Under Texas Water Code (TWC) § 13.244(d)(3) and 16 Texas Administrative Code (TAC) § 24.233(a)(6), an applicant for a certificate of convenience and necessity (CCN) or amendment to a CCN must provide a capital improvement plan, which must include a budget and estimated timeline for construction of all facilities necessary to provide full service to the entire proposed service area and must be keyed to a map showing where the facilities will be located. Please provide the following details in addition to the construction cost estimates previously provided for the Redbud Water System and WWTP:

- A. the timeline for construction of all facilities to provide full service to the entire proposed service area.
- B. a map showing where the facilities will be located relevant to therequested area.


