RESPONSE TO STAFF'S SECOND REQUEST FOR INFORMATION

- Staff 2-1 Please specify the associated public water system (PWS) and wastewater treatment plant (WWTP) that will be serving the requested areas and provide a status update on any associated permits with the Texas Commission on Environmental Quality (TCEQ).
 - a) Construction costs specify a Redbud Water and Wastewater Treatment Plant, and regarding the WWTP, the initial application specified that a TPDES permit will be transferred from Harris County Municipal Utility District No. 535 and that a water system would be submitted after the docket was assigned.
 - b) Please clarify the distinction between the TPDES Transfer Permit and the associated Redbud systems.

Answer:

Plans for the Redbud Water Plant (PWS) have been submitted to the Texas Commission on Environmental Quality. Quadvest, LP will provide the PWS number once it has been assigned. The Redbud WWTP will be serving the requested service area. The TPDES Permit (WQ0016190001) was held in the name of Harris County Municipal Utility District No. 535 and has been transferred over to Quadvest, LP. (see attached)
