# ORDER NO. 4 FINDING PETITION ADMINISTRATIVELY COMPLETE AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the April 17, 2023 petition of Gregg Lane Dev LLC to amend Aqua Water Supply Corporation's certificate of convenience and necessity (CCN) number 10294 in Travis County by streamlined expedited release. On June 19 and July 31, 2023, Gregg Lane supplemented its petition.

### I. Finding Petition Administratively Complete

On August 15, 2023, Commission Staff filed a recommendation regarding the sufficiency of the petition.

The administrative law judge (ALJ) finds the petition administratively complete.

### II. Establishing Procedural Schedule

Under Texas Water Code § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the CCN holder for the tract of land that was released. Therefore, an order granting approval for streamlined expedited release is interim in nature and, in the event the requested release is approved, the docket will continue for the purpose of determining the issue of compensation.
