- 1. "My name is Shaun Vembutty. I am over the age of eighteen years, of sound mind, and am capable of making this affidavit. The facts stated in this affidavit are within my personal knowledge and are true and correct.
- I am an authorized representative of Gregg Lane Dev LLC, the Petitioner in the above-captioned. Petitioner owns approximately 90.3 acres of land, which is located within the boundaries of water and sewer CCN No. 10294 issued to Aqua Water Supply Corporation (the "Property").
