COMMISSION STAFF’S SECOND REQUEST FOR EXTENSION

On April 18, 2023, CSWR-Texas Utility Operating Company, LLC and Circle R Ranchettes Property Owners Association (together, Applicants) filed an application for the sale, transfer, or merger of facilities (STM) and certificate of convenience and necessity (CCN) rights in Tarrant County.

On May 22, 2023, the administrative law judge (ALJ) filed Order No. 2, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application and proposed notice, and both applicants and Staff file a recommendation regarding how to proceed with the application and propose a procedural schedule by June 2, 2023. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. The Applicants are continuing to resolve its dual certification agreement with Bethesda Water Supply Corporation. Staff is also working with the Applicants to resolve several mapping issues. To allow enough time for Staff and the Applicants to resolve all issues and for Staff to review all maps once they are provided, Staff respectfully requests an extension of time to July 6, 2023. Staff has spoken with the Applicant, and they are unopposed to this request.

II. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above request for extension.
