Application of Emerald Bay Municipal Utility District and Aqua Texas, Inc. for Approval of a Service Area Contract Under Texas Water Code § 13.248 and to Amend Certificates of Convenience and Necessity in Smith County

Pursuant to Texas Water Code § 13.257, Emerald Bay Municipal Utility District (EBMUD), holder of Certificate of Convenience and Necessity No. 13047, hereby files this Boundary Description for the water and sewer service area that was removed from EBMUD's CCN No. 13047 by the PUC in an August 17, 2023 written order in Docket No. 54913. The area deleted from EBMUD's water CCN No. 13047 is approximately 4.5 acres located in Smith County, as depicted in the attached PUC map.

The Boundary Description is being filed on behalf of and at the request and instruction of Emerald Bay Municipal Utility District, based upon information and belief. EBMUD specifically authorizes the filing of this Boundary Description to comply with Texas Water Code §13.257 and its associated rules and regulation.




