### **OFFICE OF PUBLIC UTILITY COUNSEL'S REQUEST FOR A HEARING**

The Office of Public Utility Counsel ("OPUC"), representing the interests of residential and small commercial consumers in Texas, respectfully submits this request for a hearing on the merits pursuant to Order No. 5.<sup>1</sup> Pursuant to Order No. 5 the deadline to intervene in this proceeding is September 18, 2023.<sup>2</sup> OPUC filed a motion to intervene on May 9, 2023,<sup>3</sup> and the Administrative Law Judge granted OPUC's motion to intervene on May 18, 2023.<sup>4</sup> Order No. 5 establishes a deadline for intervenors to file a request for hearing on the merits by September 18, 2023.<sup>5</sup> Therefore, pursuant to Order No. 5, this request for a hearing is timely filed.
