Integra Water Texas, LLC filed with the Public Utility Commission of Texas (Commission) an application for a Class D rate/tariff change under Water Certificate of Convenience and Necessity No. 21126 in Bastrop County, Texas. The proposed increases had an effective date of June 19, 2023, which has been suspended by the Commission for no more than 265 days after June 19, 2023.

Matters that may be discussed include the appropriate effective dates, whether the applicant must provide an updated statement of intent with a new proposed effective date, pending motions, possible settlement of issues, the procedural schedule (including the hearing date), and other matters that may aid in efficient and fair processing of this case. At the prehearing conference, the parties should be prepared to discuss any pending motions, the procedural schedule including hearing dates, whether informal disposition, including mediation is appropriate for this matter, and any other relevant matters.

#### INTERVENTION

To participate as a party in this case, a person shall move to intervene either (1) in a written motion to intervene filed at the Commission no later than December 1, 2023, or (2) orally at the December 5, 2023 prehearing conference. Any filed motion shall include both SOAH Docket No. 473-24-04314 and PUC Docket No. 54940, the person's contact information, and otherwise comply with the Commission's procedural rules. Previous submission of a protest DOES NOT meet the requirement that a person who wants to participate as a party must move to intervene as described above.
