JOINT REQUEST FOR CLARIFICATION REGARDING SOAH ORDER NO. 2

COMES NOW, Integra Water Texas, LLC (Integra), the Staff of the Public Utility Commission of Texas, and the Office of Public Utility Counsel (collectively, Parties), and jointly file this clarification. The Parties would respectfully show as follows:

I. BACKGROUND

On December 5, 2023, the State Office of Administrative Hearings (SOAH) held a prehearing conference in the above-styled docket. Among other issues, the Parties and the Administrative Law Judge (ALJ) reviewed and established Integra’s proposed effective date for the requested rates.¹ The Parties ultimately reached an agreement to extend Integra’s proposed effective date to November 1, 2024.² The ALJ subsequently issued SOAH Order No. 2 memorializing the prehearing conference and the agreed to effective date.³

II. REQUEST FOR CLARIFICATION

SOAH Order No. 2 stated Integra “agreed to further suspend the effective date until November 1, 2023.”⁴ The Parties believe this may be an inadvertent error because, as discussed above, Integra and the remaining Parties agreed to an effective date of November 1, 2024. Therefore, the Parties respectfully request the ALJ to clarify the extended effective date.

III. CONCLUSION AND PRAYER

For the foregoing reasons, the Parties respectfully request that the ALJ clarify the requested rates’ effective date provided in SOAH Order No. 2.


