**JOINT STATUS REPORT**

COMES NOW, Integra Water Texas, LLC (Integra), with the consent and approval of the Office of Public Utility Counsel and the Staff of the Public Utility Commission of Texas (collectively, Parties), and files this Status Report, pursuant to State Office of Administrative Hearings Order No. 5.<sup>1</sup> In support thereof, the Parties respectfully show as follows:

**I. BACKGROUND**

On May 1, 2023, Integra filed an application for authority to change its wastewater rates.<sup>2</sup> On January 11, 2024, the Parties filed their Agreed Motion to Abate the Procedural Schedule to allow additional time for settlement.<sup>3</sup> In Order No. 4, the administrative law judge (ALJ) granted the Parties' request, abated the procedural schedule, and requested a status report by January 31, 2024.<sup>4</sup> The Parties subsequently requested additional abatement, and the ALJ requested a second status report by February 9, 2024.<sup>5</sup>

**II. STATUS REPORT**

The Parties are pleased to report they have reached a settlement in principle that resolves all issues in this proceeding.

**III. REQUEST FOR RELIEF**

The Parties respectfully request that the ALJ establish February 23, 2024, as the deadline to file a third status report or, alternatively, for the Parties to file the settlement agreement and supporting documentation.


