JOINT STATUS REPORT

COMES NOW, Integra Water Texas, LLC (Integra), with the consent and approval of the Office of Public Utility Counsel and the Staff of the Public Utility Commission of Texas (collectively, Parties), and files this Status Report, pursuant to State Office of Administrative Hearings Order No. 5.¹ In support thereof, the Parties respectfully show as follows:

I. BACKGROUND

On May 1, 2023, Integra filed an application for authority to change its wastewater rates.² On January 11, 2024, the Parties filed their Agreed Motion to Abate the Procedural Schedule to allow additional time for settlement.³ In Order No. 4, the administrative law judge (ALJ) granted the Parties' request, abated the procedural schedule, and requested a status report by January 31, 2024.⁴ The Parties subsequently requested additional abatement, and the ALJ requested a second status report by February 9, 2024.⁵ In their second status report, the Parties requested February 23, 2024, as the deadline to file a third status report or, alternatively, to file the settlement agreement and supporting documentation.⁶

II. STATUS REPORT

The Parties are still reviewing the settlement agreement and supporting documentation, and are close to finalizing the settlement package for filing.

III. REQUEST FOR RELIEF

The Parties respectfully request that the ALJ establish March 8, 2024, as the deadline to file a fourth status report or, alternatively, for the Parties to file the settlement agreement and


