**SOAH ORDER NO. 7**  
**STRIKING NON-ACTIVE PARTIES; ADMITTING EVIDENCE;**  
**REMAND TO THE COMMISSION**

On March 7, 2024, Integra Water Texas, LLC, Staff of the Public Utility Commission of Texas, and the Office of Public Utility Counsel (collectively, the Signatories), filed a Joint Motion to Admit Evidence and Remand. Simultaneously, the Signatories filed a Stipulation and Agreement (Agreement) that resolves all issues in this proceeding.

## **I. DISMISSING NON-ACTIVE PARTIES**

The deadline for intervenors Keila Cruz and Emma Delao to file a statement of position was March 15, 2024. By that date, neither filed a statement of position. THEREFORE, in accordance with SOAH Order No. 6 and 16 Texas Administrative Code sections 22.124(a) and 22.161(c) and (d), IT IS ORDERED that the intervenors listed above are STRICKEN AS PARTIES.


