## IMPORTANT CHANGES TO YOUR BILL



Dear Valued Customer:

This important message was incorrectly labeled as coming from Texas Water Utilities, L.P – It is correctly noted that:

Midway Water Utilities, Inc. is notifying you that we will be changing the City of Houston Groundwater Reduction Fee pass-through charge on your monthly bill effective on the first meter reading after May 1, 2023. We are only passing through the direct costs incurred by us for the City of Houston Groundwater Reduction Plan (GRP) as allowed by our approved tariff and PUC rules.

The current monthly usage charge on your bill is calculated as:

Gallonage		Gallonage Rates
Monthly Usage up to 10,000 gallons	x	\$2.25 per 1000 gallons
All Usage over 10,000 gallons	x	\$4.25 per 1000 gallons
City of Houston GRP Fee	x	\$1.02 per 1000 gallons

After the effective date, the new monthly charge will be calculated as:

Base Charge		Charge
Monthly Minimum Charge	x	Based on meter size per Tariff NO CHANGE

Gallonage		Gallonage Rates
Monthly Usage up to 10,000 gallons	x	\$2.25 per 1000 gallons
All Usage over 10,000 gallons	x	\$4.25 per 1000 gallons
City of Houston GRP Fee	x	\$1.38 per 1000 gallons

Monthly base charges and all other customer service charges will not change.

**This tariff change is being implemented in accordance with the minor tariff changes allowed by 16 Texas Administrative Code §24.25. The cost to you as a result of this change will not exceed the costs charged to your utility.**
