#### COMMISSION STAFF'S MOTION TO WITHDRAW

On May 1, 2023, Emerald Hills Water (Emerald Hills) filed an application to obtain a water certificate of convenience and necessity (CCN) in San Patricio County. Emerald Hills filed supplemental information on May 22,2023, June 29, 2023, July 7, 2023, August 4, 2023, August 24, 2023, and October 4, 2023.

On January 31, 2024, the Staff (Staff) of the Public Utility Commission of Texas (Commission) filed a Joint Motion to Admit Evidence and Proposed Notice of Approval. It has come to Staff counsel's attention that Sam Drugan is not eligible to practice law in Texas as evidenced by "Exhibit A" attached to this motion.

Because Staff counsel signed the Joint Motion to Admit Evidence and Proposed Notice of Approval for Sam Drugan as the attorney representing Emerald Hills and at Mr. Drugan's request, Staff moves to withdraw the Joint Motion to Admit Evidence and Proposed Notice of Approval filed on January 31, 2024.

Staff intends to coordinate with Emerald Hills to promptly file a joint motion to admit evidence and proposed notice of approval.

Staff respectfully moves to withdraw the Joint Motion to Admit Evidence and Proposed Notice of Approval filed on January 31, 2024.
