- STAFF 4-2** Describe the precise methodology used to derive a flat rate of \$76.15 per unit for the Tax Exempt Multi-family Residential rate class.
- STAFF 4-3** Provide the monthly water usage of Ariza Gosling, which may be filed confidentially, for every month of 2022 and 2023, in a Microsoft Excel workbook.
