**COMMISSION STAFF'S REQUEST FOR EXTENSION**

**I. BACKGROUND**

On May 18, 2023, NMCV Taylor Property Investors, LLC (NMCV Taylor) filed a petition to amend Manville Water Supply Corporation' s (Manville) certificate of convenience and necessity (CCN) number 11144 in Williamson County by streamlined expedited release. On May 31, 2023, NMCV Taylor filed supplemental information.

On June 21, 2023, the administrative law judge filed Order No. 2 requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission), to file a recommendation on final disposition by August 1, 2023. Therefore, this pleading is timely filed.

**II. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to review NMCV Taylor's application and supplemental information and to prepare its recommendation on final disposition. Therefore, Staff respectfully requests that the deadline to file its recommendation on final disposition be extended until August 8, 2023.

**III. CONCLUSION**

Staff respectfully requests the entry of an order consistent with the above request for extension.
