#### THE CITY OF FORT WORTH'S RESPONSE TO ORDER NO. 4

TO: Honorable Jeffrey J. Huhn, Administrative Law Judge, Public Utility Commission of Texas COMES NOW, the City of Fort Worth, by and through its counsel, and respectfully files "The City of Fort Worth's Response to Order No. 4"

#### I. BACKGROUND

On May 25, 2023, the City of Fort Worth ("Fort Worth") filed an application to amend Certificate of Convenience and Necessity ("CCN") No. 12311 and for dual certification with the City of Hurst, CCN No. 10104, ("Hurst") in Tarrant County ("Application"). The City filed supplemental information on July 26, 2023 and September 14, 2023. PUC Commission Staff filed its supplemental recommendation on administrative completeness on October 25, 2023. The ALJ found the City's application administratively complete on October 27, 2023 and adopted a procedural schedule requiring the City to publish notice to the affected parties and in a newspaper of general circulation. The ALJ gave the City until December 11, 2023 to file affidavits with the Commission regarding the City's compliance with the requirement to publish notice.

#### II. THE CITY OF FORT WORTH'S RESPONSE TO ORDER NO. 4

In response to the ALJ's order signed on October 27, 2023, the City hereby files the signed affidavits which are included and incorporated herein by reference, attesting that the City notified, by first-class mail, affected entities on November 3, 2023, and that the City published notices in the Fort Worth Star-Telegram, a newspaper of general circulation in Tarrant County, on November 6, 2023 and November 13, 2023.



# FC Dallas jump on Sounders early, tie 1st-round series

Paul Arriola and Jesus Ferreira each scored within the first 18 minutes to lead FC Dallas to a 3-1 win over the visiting Seattle Sounders on Saturday night in Match 2 of their first-round best-of-three MLS Cup playoff series.

The result sets up a winner-take-all Match 3 in Seattle next Friday.

Jader Obrian also scored for FC Dallas, while Jordan Morris tallied Seattle's only goal of the match.

The Sounders took a three-match shutout streak into Saturday's action, including their 2-0 victory over Dallas in Match 1. However, it took FC Dallas just six minutes to find the back of the net in Match 2.

Bernard Kamungo sent in a perfect arcing pass from outside the box that found an open Arriola in front of the net, and the Dallas captain's header beat goalkeeper Stefan Frei.

Kamungo was also involved in the setup of Dallas' next goal, as the striker was taken down in the box by Seattle defender Nouhou Tolo. FC Dallas were awarded an 18thminute penalty kick after a video review, and Ferreira converted it for his first career MLS playoff goal.

Echoing Dallas' quick start, the Sounders responded early in the second half. In the 48th minute, an ill-advised back pass from Kamungo toward Sebastien Ibeagha was taken away by Morris, who raced into the box and converted a wellplaced, right-footed kick.

Initially ruled an offsides play, the goal was validated after a brief discussion between the officials, giving Morris his second goal of the firstround series.

The next key ruling wasn't in the Sounders' favor, as Ferreira pulled the jersey of Raul Ruidiaz in the box when Ruidiaz was pursuing a cross in the 74th minute. Seattle wasn't awarded a penalty kick upon video review, as Ferreira's pull wasn't judged to have been an impediment to a true scoring chance.

Near-misses from Ruidiaz and Obed Vargas almost gave Seattle the equalizer before Obrian sealed FC Dallas' win in the 89th minute. Just six match as a substitute, Obrian took the ball at midfield and raced downself between two team-

should try and make." TCU had a positive drive to start the second half, but Hoover almost turned it over again as he

was sacked on third down. It was just that type of night for the quarterback. TCU had a chance to make it interesting after getting to the Texas 2-yard line late in the third quarter, but Hoover's third and fourth down pass attempts weren't close to being completed as TCU squandered a chance to get back in the game.

Hoover settled down and played better in the fourth quarter as he completed big play after big play. After just one completion of over 15 yards in the first quarter, Hoover had four in the second half, but it was too little too late.

He finished the game 24 of 36 for 302 vards, two touchdowns and the costly interception.

#### **ELITE PLAYMAKERS**

Big time players make big time plays in big time games is the saying and all of Texas' talented playmakers lived up to it. The trio of Xavier Worthy, Jonathon Brooks and Ja-Tavion Sanders were on a different level than the TCU defenders matched up against them.

Josh Newton drew the Worthy assignment and struggled with the individual matchup. Worthy had eight catches for 120 yards in the first half alone. Whether it was deep vertical shots or quick passes underneath Texas coach Steve Sarkisian did an excellent job of finding different ways to get the ball to the fastest player on the field. TCU had no answer for the All-American who finished with 10 catches for 137 yards.

Brooks hurt TCU as a runner and receiver as the league's leading rusher accounted for 181 total yards. After TCU briefly took a 3-0 lead Brooks answered by taking a

screen pass 73 yards to the TCU 2. He walked in from two yards out on the very next play.

Brooks left the game in the second half with an injury, but still finished with 104 yards on 21 car-

Sanders was a problem in the middle of the field for the TCU defense as he converted a number of crucial third downs like when Texas was facing a 3rd-and-12 and Ewers hit Sanders for a contested catch for almost 20 yards. Ewers hit Sanders again on the same drive for a 18-yard gain that helped set up a touchdown. Sanders showed why he's the best tight end in the Big 12 as he finished with four catches for 42 yards.

Ewers, who returned to the field after missing the last two games because of injury, completed 22 of 33 passes for 317 yards.

#### **BAILEY, WILLIAMS** SHINE

There were a few brights for the Horned Frogs against the Longhorns including the play of receiver Savion Williams. The hope coming into the season was Williams would emerge as the team's No. 1 option, but he had not produced like an elite receiver until Saturday.

In the first half Williams set a career-high with seven receptions and 82 yards.

In the second half Williams made a huge play as took a short catch underneath, raced up field and hurdled a defender for a 42-yard gain that would set up TCU's first touchdown of the night. He then added his sparkling offensive plays in the fourth quarter as TCU rallied. He finished with 11 catches for 164 yards.

"He's just been getting me the ball, ever since the first game," Williams said. "That's really where it started. When he was getting me the ball in the

first half it started a spark and it just kept going.

Emani Bailey finished the drive off and was TCU's best offensive option in the second half. On that same drive Bailey bounced out to the right, planted his foot and cut up field for a 17-yard touchdown that made it a two score game at the beginning of the fourth quarter.

The touchdown run took Bailey over the 1,000-yard mark and gave TCU a chance for a potential comeback.

Bailey had 21 rushes for 98 yards.

"He's one of those guys that's going to pound the rock and run tough," Hoover said. "He means a lot to us and we wouldn't be the same offense without him."

#### CRUCIAL MISTAKES

The Horned Frogs made plenty of mistakes against the Longhorns, but none was bigger than one play near the end of the first quarter. With Texas leading 7-6, Quinn Ewers launched a deep pass to Xavier Worthy that was underthrown and picked off by Millard Bradford.

The safety eluded numerous tackles for a fantastic return, but as he crossed midfield and got deeper into Texas territory he was stripped by Jordan Whittington and the Longhorns were able to fall on the fumble. Two plays later Ewers went back to Worthy on the same play and this time it wasn't under thrown as the speedy receiver picked up 45 yards.

The Longhorns only added a field goal, but the sequence summed up TCU's season. A great individual play turned into a backbreaking sequence.

'We talk all the time with our players is when a defensive player picks off a pass or picks up a fumble, the offense is going to try and strip them," Dykes said. "They're not used to carrying the football. It's a conversation we have all the time and you've got to give Texas credit."


