COMMISSION STAFF'S AMENDED PROPOSED PROCEDURAL SCHEDULE

I. INTRODUCTION

On May 25, 2023, the City of Fort Worth (Fort Worth) filed an application to amend sewer Certificate of Convenience and Necessity (CCN) No. 12311 in Tarrant County.

On October 27, 2023, the administrative law judge (ALJ) filed Order No. 4 directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on sufficiency of notice and propose a procedural schedule by December 21, 2023. Fort Worth filed a supplemental response to Order No. 4 containing supplemental notice information on December 21, 2023. Staff filed its recommendation on notice and proposed procedural schedule on December 22, 2023. However, Staff inadvertently filed the incorrect proposed procedural schedule. Therefore, Staff files this amended proposed procedural schedule.

II. AMENDED PROPOSED PROCEDURAL SCHEDULE

Staff proposes the following amended procedural schedule for continued processing of this docket:
