To whom it may concern @ the PUT please note my comments and disapproval for the Alternative Route Link I12-

The proposed alternative route link I12 in figure 2 specifically the section where it parallels HWY 114 then makes a slight bend in a northerly direction, crossing Harriet Creek Dr. then travels along the Harriet Creek and parallels Clara Love Elementary, see attached map for reference –

- A. Figure 2 does not depict the housing development just west of Clara Love Elementary, and this would impact those homes greatly in its construction and the obvious i.e., property values, known environmental hazards and the impact of lush nature filled topography.
- B. Travels directly adjacent to Clara Love Elementary School and DO Not wish to have our children exposed to the know hazards of High-Powered Transmission Lines
- C. Again, through this route section we can find it be along Side of the Northwest Independent School District High School and do not wish to expose our students to the know environmental hazards and impact of this area. It will all eliminate any future development throughout this section of land that is currently zoned for commercial use.
- D. Lastly for my personal concern the area where it is the closet to my property will not only affect the enjoyment of my residence but will also create a visual displeasing along with the inanimate reduction in my property values and expose our family as well as my neighbors to the environmental pollutions know with High-Transmission Power Lines.

We ask that this Alternative route I12 not be considered and the route J22 be the preferred Alternative route for this project. Alternative Route J22 correlates in a manner much desirable to not effect current residence in this area Figure #2 and environmental disruption such as wildlife and the known hazards with High-Transmission Power Lines because it travels in the path of existing railroad infrastructure.
