CITY OF RHOME'S AMENDED MOTION TO INTERVENE

COMES NOW the City of Rhome ("Rhome") and pursuant to the procedural rules of the Public Utility Commission of Texas (the "Commission"), 16 Tex. Admin. Code §§ 22.101 – 22.104, files this Amended Motion to Intervene as a party in the above-referenced proceeding. In support hereof, Rhome respectfully shows as follows:

- On June 8, 2023, Oncor Electric Delivery LLC ("Oncor") filed an application to amend its certificate of convenience and necessity ("CCN") for the Ramhorn Hill
 Dunham 345 kV transmission line in Denton and Wise Counties.
- Rhome is a Type A general-law municipality in Wise County whose incorporated limits and extra-territorial jurisdiction ("ETJ") would be crossed by several of the proposed segments of the Ramhorn Hill – Dunham 345 kV transmission line.
- 3. Rhome was included as one of the municipalities to whom Oncor sent notice of its application and a request for comments on the proposed transmission line.
- 4. The interests and concerns of Rhome constitute a more-than-sufficient justiciable interest in the outcome of this proceeding and accordingly confers standing on Rhome to intervene under Commission Rule § 22.103(b).

- 5. This Amended Motion to Intervene is timely filed prior to the July 24, 2023, intervention deadline established by the Commission.
- 6. Rhome's authorized representative in this docket is the undersigned attorney whose contact information is set out below. All pleadings, correspondence, notices, requests for information and other materials filed in this docket may be served on Rhome through the undersigned authorized representative.
