


Dear Commission,

This letter is in protest of the Ramhorn Hill - Dunham 345kV Transmission Line Project proposed near the Wildflower Ranch neighborhood in Denton County. More specifically routes J22, L1 and I22. We recently moved to this neighborhood, and it is distressing to learn the proposed route could bring lines through our community.

We chose to invest in this community because of the abundance of natural foliage, trees, and the proximity to wildlife. The neighborhood already has natural trails, parks, and pools for our children to enjoy.

I am protesting for a multitude of reasons. The primary reason is potential damage to our property values that the proposed routes would incur. While I'm sure you all do fine jobs, it is no secret that power lines are ugly, and most people don't want to live within view of them. The proposed lines would also mar the natural habitat and displace wildlife, who are already somewhat displaced by the growth in housing in this area. It is also of specific concern that livestock graze in the area near where the proposed lines would run. Potential placement of lines on these routes are also a health and safety concern, specifically with its proximity to the school being built in the community.

This is an area of significant housing and development growth, and while I understand the line would be beneficial, it is not in the best interest of the local community or surrounding communities that these lines run these routes.
