NOTICE OF IN-PERSON HEARING LOCATION

On June 8, 2023, Oncor Electric Delivery Company LLC (“Oncor”) filed an application to amend its certificate of convenience and necessity for the Ramhorn Hill-to-Dunham 345 kV transmission line in Denton and Wise counties. On June 26, 2023, the State Office of Administrative Hearings (“SOAH”) Administrative Law Judge (“ALJ”) convened a prehearing conference at which Oncor requested an in-person hearing on the merits. Staff did not object to an in-person hearing, provided there is hybrid capability to allow parties who wish to participate remotely to do so. Oncor agreed to secure a venue for the hearing on the merits if the SOAH hearing room with hybrid capability was unavailable on the agreed hearing dates of **August 28-31, 2023**. Oncor also agreed to notify the parties of the in-person hearing location by August 4, 2023. In SOAH Order No. 2, the ALJ informed the parties that the SOAH hearing room with hybrid capability is not available on the agreed hearing dates.

Oncor has secured a meeting space in Austin, Texas that can accommodate 175 people for the duration of the hearing. Oncor also secured professional audio/video services to provide reliable hybrid capability for the hearing. Thus, all parties wishing to participate in the hearing on the merits remotely or in person may do so. The in-person meeting space is located at:
