# ONCOR ELECTRIC DELIVERY COMPANY LLC'S NOTICE REGARDING SECOND SUPPLEMENTAL AFFIDAVIT ATTESTING TO THE PROVISION OF NOTICE TO LANDOWNERS AND REQUEST FOR APPROVAL

Oncor Electric Delivery Company LLC ("Oncor") files the attached Second Supplemental Affidavit Attesting to the Provision of Notice to Landowners ("Second Supplemental Affidavit of Notice") for the Ramhorn Hill to Dunham 345-kV transmission line project in Denton and Wise counties. Pursuant to 16 Texas Administrative Code ("TAC") § 22.52(a)(3)(E), Oncor provides notice of, and if necessary seeks approval for, the supplemental notices discussed herein.

Oncor filed its original Affidavit Attesting to the Provision of Notice to Landowners in this proceeding on June 28, 2023 ("Original Affidavit of Notice"). The State Office of Administrative Hearings ("SOAH") Administrative Law Judge ("ALJ") found Oncor's notice sufficient in SOAH Order No. 2, issued June 28, 2023. On July 13, 2023, Oncor filed a Supplemental Affidavit of Notice to update the Commission regarding notices that were returned to Oncor and re-sent to landowners after the Original Affidavit of Notice was filed ("First Supplemental Affidavit of Notice").

Since filing the First Supplemental Affidavit of Notice, Oncor learned of additional landowners who did not receive the originally mailed notices. Pursuant to 16 TAC § 22.52(a)(3)(E), Oncor re-sent notices to these landowners, in compliance with the Commission's CCN notice rule. Oncor files the attached Second Supplemental Affidavit of Notice to notify the Commission of these additional returned and re-sent landowner notices.

The Original Affidavit of Notice, First Supplemental Affidavit of Notice, and Second Supplemental Affidavit of Notice together satisfy the requirements of 16 TAC § 22.52(a)(3). Accordingly, Oncor requests that the ALJ approve the supplemental landowner notices, if necessary, with an intervention deadline for such landowners of fifteen days from the date of the landowner's receipt thereof.
