I. GRANTING LATE-FILED MOTIONS TO INTERVENE

II. DEADLINE FOR APPLICANT TO FILE WRITTEN LIST OF INTERVENORS

Pursuant to SOAH Order No. 1, by no later than August 11, 2023, Oncor Electric Delivery Company LLC must file its written list of all intervenors who did not file direct testimony or a statement of position.

III. ADVISORY FOR INTERVENORS

Due to the large number of intervenors, it is strongly encouraged that any party that plans to attend and participate in the hearing on the merits register their intent to appear via Zoom¹ in advance with the State Office of Administrative Hearings (SOAH).

Parties may register by going to SOAH's website at www.soah.texas.gov, locating the registration form under the heading "E-Services", and selecting the "Register for a Public Hearing" tab. The registration form for this proceeding will be identified by the applicable SOAH and Commission docket numbers.

Prior to the hearing on the merits, an intervenor appearing via Zoom videoconference should ensure that (1) they can access Zoom, (2) that their audio and video are working, and (3) that they are named in Zoom in a manner that adequately identifies themselves and/or the party they represent.
