## SOAH ORDER NO. 9 DISMISSING INTERVENORS AND REVISING RECORD REQUIREMENTS

#### I. DISMISSING INTERVENORS

SOAH Order Nos. 1 and 2 informed intervenors that failure to timely file either written testimony or a statement of position will result in dismissal as a party from this proceeding and prohibited from further participation.<sup>1</sup> On August 11, 2023, Oncor Electric Delivery Company (Oncor) filed a list of intervenors who did not file direct testimony or a statement of position.

Accordingly, the ALJs **GRANT** Oncor's request to strike these intervenors. The intervenors identified above are **DISMISSED** from this proceeding and shall be **STRUCK** from the service list.

Furthermore, the ALJs cannot determine from the docket whether Bobby Norris (as identified in Request to Intervene, Item No. 985, July 24, 2023) and Keith Norris (as identified in the Direct Testimony of Keith Norris, Item No. 1435, July 31, 2023) are the same person. It is therefore **ORDERED** that **by no later than August 17, 2023,** counsel for Keith Norris shall file clarification as to whether these filings relate to the same person.

### II. REVISING RECORD REQUIREMENTS

The language below modifies instructions included in SOAH Order No. 2:

#### **Before the Hearing**

No later than 3:00 p.m. on August 23, 2023, the parties SHALL comply with the following prehearing requirements:

- 1. Applicant **SHALL** arrange to have a court reporter transcribe the hearing.
- 2. Applicant **SHALL** file a list of persons who have signed the Protective Order.
- 3. Each party **SHALL** file a list of all witnesses the party expects to call to testify during the hearing and identifying witnesses, if any, for whom all other parties waived cross-examination.
- 4. The parties **SHALL** file a notice of an agreed-upon order of presentation of witnesses and cross-examination order by parties.
- 5. Each party SHALL file a list of all exhibits it intends to offer at the hearing (including, for example, on cross-examination). The list shall identify any exhibit containing Protected Materials or Highly Sensitive Protected Materials under the Protective Order issued in this case.
- 6. Each party **SHALL** upload all hearing exhibits (excluding cross-examination exhibits) and an exhibit list to a file-sharing site to be provided by Oncor. The list shall identify any exhibit containing Protected Materials or Highly Sensitive Protected Materials under the Protective Order issued in this case.
- 7. Parties will not be required to serve hard copies of exhibits to other parties so long as they upload accurate copies of the exhibits to Oncor's file-sharing site.

- 8. Parties SHALL provide to the court reporter all exhibit and witness lists in MS Word format and all exhibits in electronic form, including pre-filed testimony exhibits and workpapers.<sup>2</sup>
- 9. Parties may share the exhibits with the court reporter by providing (1) a USB or flash drive; or (2) access to a secure, electronic filesharing site (which shall include login instructions).
- 10. The parties SHALL exchange a marked copy of all exhibits not containing Protected Materials or Highly Sensitive Protected Materials that they intend to offer at the hearing.<sup>3</sup> In compliance with 16 Texas Administrative Code § 22.71(d) and the Protective Order, any party intending to offer exhibits containing Protected Materials or Highly Sensitive Protected Materials SHALL also provide those exhibits to the other parties who have signed the Protective Order.

#### **During the hearing:**

No later than 7:00 p.m. before each day of the hearing on the merits, each party shall upload to Oncor's file-sharing site any cross-examination exhibits a party anticipates using during the following day of the hearing of the merits. The parties shall also email, or electronically deliver any exhibits to Kennedy Reporting by the 7:00 p.m. deadline. Updated exhibit lists shall be uploaded to the file-sharing site at the same time a party uploads its additional exhibits, if there are additional crossexamination exhibits.

#### After the hearing:

- 1. No later than September 5, 2023, the parties shall submit a final, record set of exhibits in electronic format to the court reporter, which contains all exhibits that were admitted as evidence or accompanied by an offer of proof. 1 Tex. Admin. Code § 155.101(b)(1)(G)(iii).
- 2. The parties shall submit the exhibits with the court reporter by (1) providing a CD, USB, or flash drive; or (2) making a secure, electronic filesharing site available of the admitted exhibits. All exhibits should be readily identifiable by specific folder (*e.g.*, Applicant Admitted Exhibits, Staff Admitted Exhibits, etc.).

All exhibits **SHALL** be marked with the offering party's name and the exhibit number. Exhibits should be numbered sequentially, and multipage documents shall be paginated or Bates-stamped. Exhibits not meeting a requirement in this Order may not be admitted into the record absent good cause.

**Before the hearing**, the parties **SHALL** provide to witnesses all documents necessary for their effective participation in the hearing. Parties should also speak to the witnesses they intend to call to testify and provide them the necessary videoconferencing information.
