NOTICE OF COMPLIANCE WITH SOAH ORDER NOS. 2 AND 9, WITNESS LIST,
EXHIBIT LIST, NOTICE OF AGREED ORDER OF PRESENTATION AND
PROTECTIVE ORDER LOG, AND REQUEST FOR ALJ’S IN-PERSON ATTENDANCE**

I. INTRODUCTION

On June 8, 2023, Oncor Electric Delivery Company LLC (“Oncor”) filed an application to amend its certificate of convenience and necessity for the Ramhorn Hill-Dunham 345 kV Transmission Line Project. On June 28, 2023, the State Office of Administrative Hearings (“SOAH”) Administrative Law Judges (“ALJs”) issued SOAH Order No. 2, which adopted a procedural schedule, set a date for the Hearing on the Merits (“Hearing”), and established certain record requirements and deadlines for participation in the Hearing. On August 16, 2023, the SOAH ALJs issued SOAH Order No. 9, revising certain record requirements established in SOAH Order No. 2 (SOAH Order No. 2 and SOAH Order No. 9 together, the “SOAH Orders”).

In addition to addressing the record requirements established in the SOAH Orders, this pleading respectfully requests the ALJs’ in-person attendance at the Hearing. That issue is addressed in Section III, below. The SOAH Orders, addressed in Sections I and II, require the parties to comply with the following deadlines:

- (i) By August 22, 2023, Oncor must email the name of the file-sharing site to be used by the parties to the ALJs’ administrative assistant.
- (ii) By August 23, 2023, at 3:00 PM, Oncor must:
 - (a) Arrange to have a court reporter transcribe the hearing; and
 - (b) File a list of persons who have signed the Protective Order.
- (iii) By August 23, 2023, at 3:00 PM, each party must:

- (a) File a list of witnesses the party expects to call to testify during the hearing and identifying witnesses, if any, for whom all other parties waived cross-examination;
 - (b) File notice of an agreed-upon order of presentation of witnesses and cross-examination by the parties;
 - (c) File a list of all exhibits it intends to offer at the Hearing (including, for example, on cross-examination), which list shall identify any exhibit containing Protected Materials or Highly Sensitive Protected Materials under the Protective Order;
 - (d) Upload all hearing exhibits, including cross-examination exhibits, and an exhibit list to the file-sharing site to be provided by Oncor;
 - (e) Provide to the court reporter all exhibit and witness lists in Microsoft Word format and all exhibits in electronic form, including pre-filed testimony, exhibits, and workpapers; and
 - (f) Exchange a marked copy of all exhibits (including providing copies of exhibits that contain Protected Materials and Highly Sensitive Protected Materials only to parties who have signed the Protective Order). Parties are not required to serve hard copies of exhibits to other parties so long as they upload accurate copies of the exhibits to Oncor's file-sharing site.
- (iv) By August 24, 2023, each party must provide one hard copy of all exhibits the party intends to offer at the hearing to the SOAH ALJs at Room 504, 5th Floor, William P. Clements Building, 300 West 15th Street, Austin, Texas 78701.

Oncor timely provides the SOAH ALJs with this notice that it has complied with the pre-hearing record requirements. Attached hereto is Oncor's exhibit list, Oncor's witness list, an agreed order of presentation, and a Protective Order log.

II. ONCOR'S COMPLIANCE WITH SOAH ORDER NOS. 2 AND 9

- (i) *File-Sharing Site and Instructions* – On August 22, 2023, Oncor timely shared with the ALJs' administrative assistant information regarding the Egnyte file-sharing site hosted by Oncor. On August 22, 2023, Oncor notified the parties that Egnyte will host the Hearing Folders. On August 23, 2023, Oncor emailed personal invitations to each party, or the party's representative, to provide access to the party's Hearing Folder. Oncor's emails on August 22-23, 2023, included instructions for accessing Egnyte, which are provided below for convenience:

- (a) Accept the invitation received via email by clicking on *Accept Invitation* (a username is provided in this email).
 - (b) Two Factor Authentication is required. Click *Get Started* then choose *Use Phone Number* as security method and click *Next*.
 - (c) Verify your phone number by inputting mobile number, click *Next*. Choose *Use Text Messages*, click *Next*. Enter the security code sent to the mobile number previously provided, click *Next*. Your phone number is now confirmed. Click *Skip*.
 - (d) Set up your account by creating a password (must be 12 characters). Choose preference for profile picture, if desired, or click *Not Now*. Please retain your user name and password along with the link to Egnyte site for future reference.
- (ii) *Court Reporter* – Oncor engaged Kennedy Reporting Service to transcribe the prehearing conference and the Hearing. Questions for the court reporter and requests for a copy of the transcript can be directed to: order@kennedyreporting.com.
 - (iii) *Protective Order Log* – Attachment 1 to this notice provides a list of all persons who have signed the Protective Order as of August 23, 2023.
 - (iv) *Witness List* – Attachment 2 to this Notice provides a complete list of witnesses Oncor currently intends to cross-examine at the Hearing. On August 23, 2023, Oncor uploaded an accurate copy of Attachment 2 to Oncor's Egnyte Hearing Folder in Microsoft Word format. In addition to the witnesses specified on the witness list, Oncor reserves the right to: (1) cross-examine the witness(es) of any party that cross-examines any of Oncor's witnesses; and (2) cross-examine any witness that any other party calls for cross-examination. All of Oncor's witnesses will be available for cross-examination at the Hearing, including Mr. Harsh Naik, Mr. Russell J. Marusak, Ms. Amy L. Zapletal, Ms. Brenda J. Perkins, and Dr. Edward P. Gelmann. However, Dr. Gelmann is only available for cross-examination on August 30, 2023. Oncor respectfully requests that all parties who wish to cross-examine Dr. Gelmann be required to do so on that date.
 - (v) *Exhibits and Exhibit List* – Attachment 3 to this notice includes a complete list of Oncor's exhibits, including cross-examination exhibits, that Oncor currently intends to offer at the Hearing. On August 23, 2023, Oncor uploaded an accurate copy of Attachment 3 to Oncor's Egnyte Hearing Folder in Microsoft Word format. Each exhibit identified in the exhibit list was timely uploaded to Oncor's Egnyte Hearing Folder. Oncor reserves the

right to offer additional exhibits responsive to live testimony elicited, and arguments made, by other parties at the Hearing

- (vi) *Order of Presentation* – Attachment 4 to this Notice provides the agreed order of presentation of intervenor witnesses and cross-examination at the Hearing. At the settlement conference held on August 17, 2023, all parties in attendance agreed on this order of presentation. Oncor emailed the order of presentation to all parties who provided an email address in this docket and requested a response from any party who objects to this order of presentation.¹ No party objected.

In order to streamline the Hearing and assist the parties in organizing their redirect, Oncor proposes the parties proceed with their direct and cross-examination in the following order:

Presentation of Witnesses

- Oncor (direct case)
- Intervenor Parties (direct and cross-rebuttal cases)
- Commission Staff
- Oncor (rebuttal case)

Cross-Examination

- Intervenor Parties
- Commission Staff
- Oncor

- (vii) *Copies of Exhibits, Exhibit Lists, and Witness Lists*

- (a) To the Court Reporter – Kennedy Reporting Service requests that all parties provide their exhibits, exhibit lists, and witness lists to the court reporter by uploading them to the party's Egnyte Hearing Folder.
- (b) To the Parties – On August 23, 2023, Oncor uploaded accurate copies of its exhibits to Egnyte. All parties can view and download a copy of Oncor's exhibits from Oncor's Hearing Folder.
- (c) To the ALJs – On August 23, 2023, Oncor sent one hard copy of all exhibits Oncor intends to offer at the Hearing to SOAH, at the address provided, via overnight delivery.

¹ Intervenor Russell Sherwood did not provide an email address.

Additionally, the ALJs can view and download a copy of Oncor's exhibits from Oncor's Hearing Folder on Egnyte.

III. REQUEST THAT ALJS PRESIDE OVER HEARING IN PERSON

As explained in Oncor's Notice of In-Person Hearing Location, filed August 4, 2023, Oncor secured a large meeting space to facilitate in-person attendance at the Hearing for all parties who wish to attend. On August 22, 2023, Oncor polled the parties regarding their preferred method of participation. Currently, more than 85% of the parties represented in the responses indicated a preference for in-person attendance. Oncor welcomes anyone who wishes to participate in the Hearing in person. CCN proceedings such as this one involve careful consideration of highly technical issues and examination of large, detailed maps. Attending the hearing in person greatly enhances the efficiency and clarity of the proceeding for all involved, promoting focused participation and engagement. In-person attendance also mitigates the potential for unforeseen distractions that commonly interfere with efforts to participate remotely in an interactive group setting. A greater number of in-person attendees will create fewer opportunities for these types of issues to arise.

In particular, Oncor would welcome, and respectfully requests, the ALJs' in-person attendance at the Hearing. As the presiding officers, the ALJs' in-person attendance would benefit all parties by maximizing their ability to fully participate in the proceeding. With approximately one hundred parties currently in the docket, this Hearing will be uniquely susceptible to unforeseeable issues that may distract from the substance of the proceeding. The ALJs' in-person attendance will contribute greatly to creating a focused, efficient hearing environment.

IV. CONCLUSION

Oncor has complied with all pre-hearing record requirements in the SOAH Orders and respectfully requests that the ALJs attend the Hearing in person.
