JOINT STATEMENT OF POSITION

TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

The Western Parties listed below file this Statement of Position pursuant to 16 Texas Administrative Code (TAC) § 22.124(a), and in support thereof would respectfully shows:

I. BACKGROUND

On June 8, 2023, Oncor Electric Delivery LLC (Oncor) filed its application to amend its certificate of convenience and necessity for the Ramhorn Hill to Dunham 345 kV transmission line (Transmission Line) in Denton and Wise Counties (Application). Pursuant to 16 TAC § 22.124, each party that has not pre-filed direct testimony and, insofar as its pre-filed direct testimony does not address issues that a party intends to litigate, each party that has pre-filed direct testimony is required to file a statement of position no later than three working days before the start of a hearing unless the presiding officer determines that such a requirement would add unjustified burden and expense to the proceeding, or that a different deadline should be imposed. Therefore, this Joint Statement of Position is timely filed.

II. JOINT STATEMENT OF POSITION
