You state on Page 8, Line 29 through Page 9, Line 1 of your rebuttal testimony that, "[b]oth Route 148 and Route 179 are viable options for the Commission to consider, as are all routes presented in the Environmental Assessment" (emphasis added). However, PUC Staff's recommended Route 179-C (which is identical to Route 179-Watkins) was not originally presented in the Environmental Assessment.

- a. Do you consider Route 179-C a viable option for the Commission to consider?
- b. If the answer to Part a. is "yes" or otherwise affirmative, can you also support PUC Staff's recommended Route 179-C?
