Please also refer to Oncor's response to DCLC RFI 1-3, which addresses modified versions of Link M3 proposed by Denton County Land and Cattle.

The following response was prepared by or under the direct supervision of Russell J. Marusak, the sponsoring witness for this response.


Please refer to Oncor's response to DCLC RFI 1-3, which includes environmental data for Link M3 and modified versions of Link M3 as provided by DCLC.

Halff identified several oil and gas wells on properties now understood to be the GRBK/GBTM properties. Link M3 crosses what has been identified by as the GRBK/GBTM permitted well area. Historical aerial imagery shows that the well was constructed between 1990-1995. No evidence of disturbance or prior facilities extended into the filed Link M3 alignment. Attachment 1 shows approximate distances of above-ground facilities relative to the filed Link M3 alignment.
